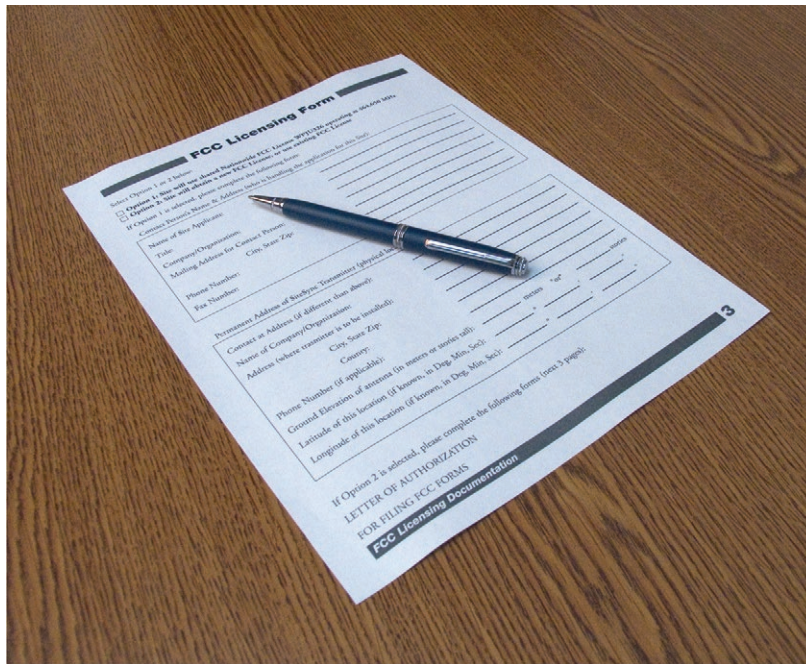

FCC Licensing Forms



Dear American Time Customer,

Thank you for your interest in our SiteSync IQ Wireless Clock System. We believe you will find this system to be a great choice to serve the needs of your time sensitive facility.

There is one important detail to be considered before ordering the SiteSync IQ Wireless System components. In the United States, this system operates on FCC (Federal Communications Commission) licensed frequencies, in the 450-470 MHz range.

There are two options for FCC licensing:

Option 1: Use shared Nationwide FCC License WQFW336-operating at 464.600, 464.625, 464.650, 464.675, 464.700 MHz and controlled by American Time & Signal Co. (See Form 1566)

Option 2: Obtain your own FCC License (See page 3-4)

Note: Frequency will be 1-way paging channel (1 of 9 from the list below):

- 462.750 MHz
- 462.775 MHz
- 462.800 MHz
- 462.825 MHz
- 462.850 MHz
- 462.875 MHz
- 462.900 MHz
- 462.925 MHz
- 465.000 MHz

Option 2: Obtain your own FCC License

American Time will assist you with the process of obtaining this license. AT will complete the paperwork and submit it to our frequency coordinator for licensing by the FCC. You will be assigned a frequency and the transmitter, clocks, and other system components will be factory programmed with your frequency.

For Option 2, fill out the form on page 3 and sign on page 4.

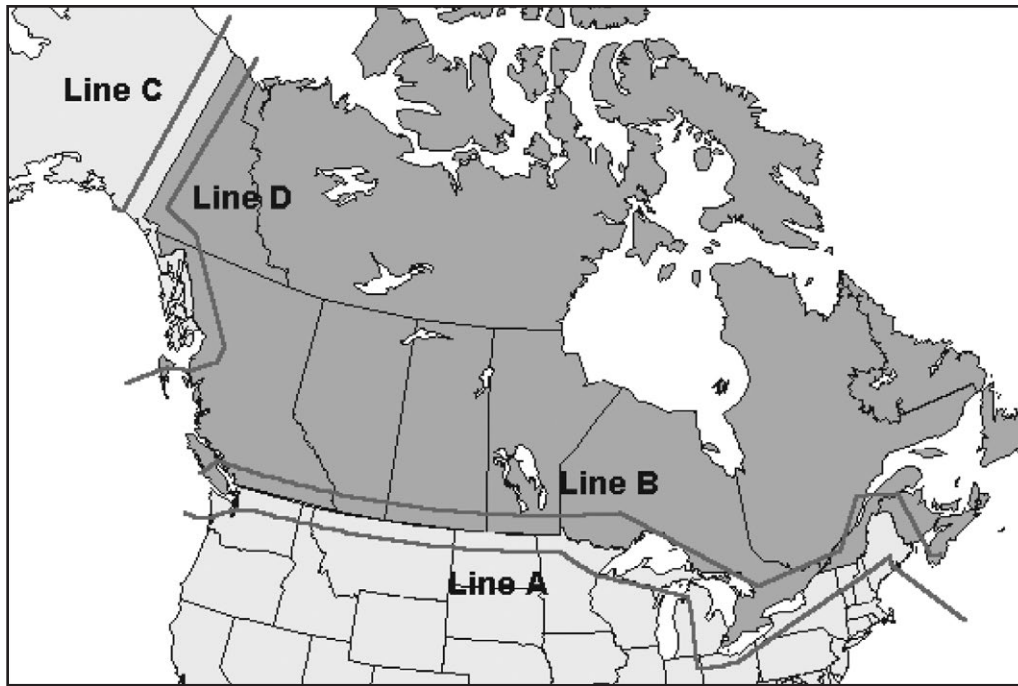


Figure 1: Lines A & C near Canada

Note: Locations in the United States North of Line A or East of Line C will require frequency coordination between the US and Canada. Locations in these regions, operating over 5 watts, cannot use the Nationwide Shared License (option 1).

The FCC defines frequency coordination as: “The process of obtaining a frequency that will most effectively meet the applicants needs while minimizing interference to licensees already operating in the band.”
